

Develop district/school assessment decision rules. Build the capacity of teachers to use collected data to make meaningful instructional decisions.
Literacy Curriculum Review and Adoption	 Review current literacy curricular materials and determine the need for adjustments. Select and adopt evidence-based curricular materials.
Coaching for Literacy Leaders	 Create and sustain a district literacy leadership team. Develop or refine the district or school's literacy mission, vision, and framework. Develop data cycles and protocols for continuous improvement in literacy.
Literacy Data Analysis for Decision Making	 Train your literacy leadership team to use data to make literacy programming decisions, such as evaluating literacy program outcomes and determining system goals and action steps. Build the capacity of teachers to use a systematic process to analyze data to inform instructional decisions.
Literacy Teacher as Researcher	 Train and coach teachers to evaluate how evidence-based instructional strategies for literacy and language are supporting their students. Provide teachers with access to a database of proven teaching methods for reading and writing instruction.
